Introduction

FCJ Primary School (FCJ School) has produced this School Travel Plan (STP) to improve road safety, to reduce the impacts of vehicular traffic around the school and to promote sustainable choices for travel for the well-being of schoolchildren, parents/carers and school staff. We also take into consideration access points through Grainville School site and on the adjacent road network used for school access.

At FCJ School we recognise the uniqueness of each individual and we learn to respect this as we prepare our children for life in the wider world. We do not forget that we are part of a process; we want our children to go onto the next stage of their education with a built-in desire for further learning experiences and opportunities. It is also our aim to provide a secure and safe environment where children feel valued and happy. FCJ believes that parents re the chief educators of their children and so the school places great emphasis on working in partnership with them.

The Travel Plan aims to:

- Improve road safety for travel to and from the school
- Better manage vehicular access and routing to school
- Promote alternate modes for travel to school and reduce the dependency of private car travel
- Promote awareness on the environmental impacts of travel mode decisions
- Increase walking and cycling to school, for children who live locally
- Reduce traffic congestion generated by school activity

The School Travel Plan includes recommendations and actions to improve road safety, access and parking to FCJ, access and movement through our neighbouring Grainville School site and the adjacent road network.

There is a need to improve the safety of all road users in particular schoolchildren during the school drop-off and pick-up period. The high traffic flows during the morning and evening peak traffic periods on St Saviour's Hill pose a road safety risk to our students and school community. There is also the environmental and health impacts of exhaust emissions generated by motorised vehicles.

The incorporation of the School Travel Plan into the curriculum will help students develop their road safety awareness, responsible attitudes towards other users, and their awareness of the effects of their travel choices; all of which they can take into their adult lives. This plan demonstrates FCJ School's responsibility in taking action to improve the health, well-being and safety of the students and staff at the school and to improve the environment of the community in which people live.

This School Travel Plan sets out recommendations on actions to improve road safety, access and car parking on the school's service road at and the adjacent external road network.

The School Travel Plan will:

- > Encompass all travel/ transport actions for the school;
- > Set out a process where the school works in partnership with staff, parents/carers and other stakeholders to promote safe and sustainable travel; and
- ➤ Be created in consultation with the whole school community, the adjacent Grainville School and takes account of current trends and the local situation

Update of the 2013 School Travel Plan

This 2019 School Travel Plan will supersede the 2013 School Travel Plan.

1 School Information

1.1 Introduction to the School

FCJ Primary School was established in Jersey since 1911. The original school and site are now home to Grainville Secondary School, which is run by the States of Jersey. As part of this agreement, a legal covenant was established to ensure that FCJ maintains a legal right of way over Grainville's land for the purposes of accessing the FCJ site. This includes the Deloraine Rd entrance, the footpath from the Grainville Playing Fields car park and the service road past Grainville School. The Preparatory School remained and became known as FCJ Primary School. Further building extensions were made to FCJ Primary School in 1996 and, in 2002 the school received a capital works grant from the States of Jersey and completely refurbished the school. In September 2014, the school became a two form entry school.

1.2 School Location

Figure 1 shows FCJ Primary School location on Deloraine Road, St Saviour. The school has an Island-wide catchment; students are admitted to FCJ Primary School on a non-selective academic basis.

Figure 2 shows the existing FCJ School layout plan. The school comprises of the primary school building, playing fields in front of the school and paved playground at the back of the school (back playground). The main school vehicular and pedestrian access is off the service road, where there are 18 staff car parking spaces and two school minibuses parking spaces in front of the school.

1.3 Students and Staff

There are 332 students enrolled at the FCJ from Foundation Stage to Year 6 as follows:



The school employs 35 teaching and school support staff.

Almost 65% of the students live 2 miles or further from the school. Only a small number of students (19%) live less than a mile from the school



1.4 School Operation

FCJ School has introduced staggered the school hours to reduce the impacts of school traffic. FCJ's school day commences for Key Stage 1 from 8:40 to 15:00, and for Key Stage 2 from 8:40 - 15:10. During the first term, Reception children may enter their classroom from 8:30 rather than wait on the playground with the other children until 8:40.

Activity	Description	
School drop-off	The school gates open at 8:30 on school days. Parents/guardians who drive have the choice of:	
	 Kiss 'n drive at the roundabout where two members of staff escort the children from the left-hand passenger door of the car. Parents/ guardians remain in their vehicle, which allows traffic to flow smoothly and exit the service road past Grainville school. 	
	 Park 'n stride by parking at the Grainville Playing Fields car park and walking the children down to FCJ School, via the footpath to a zebra crossing in front of Grainville School. After the crossing, walk around the planters beside the roundabout to enter FCJ School. 	
School pick-up	Parents/ guardians who drive have the choice of:	
	 Parking on the FCJ School back playground. The rear gate off Deloraine Road opens at 14:45 and parents/ guardians drive in and park on the back playground as directed by a member of staff. Children must be collected from the appropriate school door and escorted to the car between 15:00 and 15:10. Vehicles are required to leave the premises promptly to reduce queuing on Delorraine Road to allow other parents to enter the car park. Vehicles exit 	

via the main vehicular entrance past the roundabout into the service road. Parents/ guardians may park in the Grainville Playing Fields car park and walk down to FCJ School, as during the morning drop-off. Staff travel Staff generally arrive at the school between 7:00 and 8:15 and leave the site any time after 16:00. FCJ currently manage a comprehensive rota for on-site car parking within the school compound. Staff who are not allocated on-site car parking space park at the Grainville Playing Fields car park. Visitors to the There is no visitor car parking provision at FCJ School. Visitors School are required to park in the Grainville Playing Fields car park and walk down to FCJ School though the same pedestrian route taken by schoolchildren. **Delivery** and No delivery and servicing is permitted during the school drop-Servicing off/ pick-up periods. Refuse collection is collected from FCJ school from the side of the school off Deloraine Road. Deliveries and servicing take place through the FCJ school main vehicular entrance. Delivery and servicing activity is scheduled in advance in agreement with the school. Goods and delivery vehicles park at the school minibus bays or double-park on the school driveway within the school

compound.

2 Transport Links to the School

2.1 Pedestrian Access


The pedestrian provision within and external to the school is shown in Figure 3. The School encourages parents to park at the Grainville Sports Field and walk their children to/ from school from that car park to reduce drop-off /pick-up traffic at the school.

Location	Description
External Road Network	The pedestrian footpath along St Saviour's Hill (Figure 1) is narrow for this major road and is discontinuous on some sections. The lack of high quality and continuous footpaths on this road is a significant barrier for walking and cycling to school.
	There is a continuous, segregated footpath that runs parallel to Deloraine Road connecting St Saviour's Hill with the Grainville Playing Fields south car park. The zebra crossing on St Saviour's Hill at the northern end of this footpath provides a safe passage for pedestrians. Pedestrians have a marked route through the southern Grainville Playing fields car park to reach the footpath that connects into to FCJ School.
	There is no continuity of pedestrian footpath in the east-west direction from FCJ School into Langley Avenue.
	At the roundabout adjacent to the FCJ School main entrance, pedestrians are required to walk on the carriageway around the planters beside the roundabout to enter FCJ School.
Within the School Compound	There are no marked pedestrian routes within the school compound

2.2 Cyclists Access

The footpath's along St Saviour's Hill is narrow to be used as a shared pedestrian and cyclists route. St Saviour's Hill between St Helier and the school involves cycling uphill which may be challenging for primary schoolchildren.

The local road network immediately outside the school does not offer a safe cycling environment for younger cyclists. The lack of high quality and continuous footpaths on this road is a significant barrier for walking and cycling to school. Hence, cycling is not considered to be a suitable sustainable mode of travel to/from school for FCJ School.

2.3 Public Transport Access

The closest public bus stop to FCJ School is sited off a dedicated bus lane and layby at the Grainville Playing Fields car park. There is a continuous footpath linking FCJ School to this bus stop. There are other bus stops on St Saviour's Hill, but these require a longer walk.

2.4 FCJ School Bus

FCJ School benefits from a dedicated school bus service, which is run by Liberty Bus. The FCJ School bus shuttles between the roundabout outside the school and Wellington Hill by De La Salle/Beaulieu schools. Currently, up to 44 children use this school bus service. There is no parental supervision on the bus and parents are required to sign an agreement to take on responsibility for their children's behaviour on the bus.

2.5 Vehicular Access

Vehicular access to the FCJ School and the adjacent Grainville School is through the 2-way residential Deloraine Road off St Saviour's Hill. Deloraine Road becomes a one-way road in the direction towards St Saviour's Hill at the rear of FCJ School.

The main vehicular entrance to FCJ School is through a roundabout on a one-way service road off Deloraine Road. Vehicles exit FCJ School and return into the one-way service road that leads into Swan Farm Lane/ Langley Avenue.

There is a rear vehicular entrance into FCJ School to the south of Deloraine Road that is opened for use during the after-school pick-up period. Vehicles drive through the back playground area and exit through the school's main vehicular entrance.

The adjacent Grainville Playing Fields car park consists of 2 segregated parking areas which can be accessed either from St Saviours Hill or from Deloraine Road.

3 The Existing Situation

The main travel challenges facing the school relate to road safety, car parking and the need to encourage schoolchildren to adopt sustainable travel practices for travel to and from school.

There is a high dependency on private car use for travel to and from school (84%) despite slightly more than a third (37%) of schoolchildren living within 2 miles of the school.



Unlike typical Parish schools in Jersey, as FCJ School is a fee-paying faith school, its students come from an island-wide catchment on a non-selective academic basis. The widespread distribution of students living across the island affects their mode of transport to school and the options that are available to them to adopt sustainable travel practice.

3.1 Provision to Support Sustainable Travel in School

Item	Provision
Car parking spaces in the	18 staff car park bays
school compound	There is no disabled car parking space
	Visitors are not allowed to park at the staff car park in the school compound.
Visitor car parking	Visitors are required to park at the adjacent Grainville Playing Fields car park. This is a SoJ Yellow Parking Disc car park which has a 3 hours maximum parking restriction in any 24 hours on Mondays to Fridays.
Covered waiting area for pick-up/ drop-off	At the school main building only. There is no shelter from the weather on footpaths leading to car park nor at the bus layby at the Grainville Playing Fields car park
Cycle and scooter parking facility	There is no cycle or scooter parking provision in the school
Shower facilities	Available for use by school staff only

3.2 Site Audit

The Site Audit undertaken in June 2019 identified the following issues relating to road safety, site access, vehicular operation and car parking at the school.

Issue	Details
Vehicular	Parking in school compound is limited to staff vehicles. Parents and visitors are not permitted to drive into the school.
operation in school compound	Deliveries and servicing takes place within the school compound but this activity is timed to take place outside the school pick-up and drop-off periods. Better co-ordination is required by Grainville School.
Morning drop-off at the roundabout	The morning drop-off system is well managed by school staff with good co-operation by parents/carers making the drop-off. This is observed to be operating in an orderly manner during all weather conditions.
outside the school	Parents/ carers who wish to park their vehicles do so at the Grainville Playing Fields car park so as not to create congestion at the roundabout.
Pedestrian and vehicular activity at the Grainville Playing Field car park	Pedestrians have a marked passage through the Grainville Playing fields car park. The double parking of vehicles in the car park during school pick-up and drop-off periods require pedestrians to weave between parked vehicles resulting in an unsafe environment for pedestrians.
	Pedestrians do not use the marked zebra crossing in front of Grainville School but instead walk randomly across the school service road to travel between the Grainville Playing Fields car park and FCI School putting themselves at risk.
Footpath links to school	At the roundabout adjacent to the FCJ School gate, pedestrians are required to walk on the carriageway around the planters beside the roundabout to enter FCJ School. The exposure of pedestrians to traffic puts pedestrians at risk of being side-swept by vehicles travelling through the roundabout
Car parking for school pick-up/drop-off	The after-school pick-up takes place at the FCJ School rear playground which is accessed through Deloraine Road. School staff manage this operation and control the flow of vehicles into the playground by holding vehicles on Deloraine Road. This can create queues on Deloraine Road.

There is a risk to pedestrians being side-swept by vehicles when both share the roadway at the back playground despite vehicles being driven at very low speeds. This is a concern mainly as parents/ guardians and schoolchildren are observed to walk between parked and moving traffic.

3.3 School Travel Plan Survey Findings


A total of 165 responses was obtained from the June 2019 Parent/Guardian School Travel Plan Survey, giving a 65% response rate. This online survey was undertaken between 26/6/19 and 28/6/19. The survey results are attached in Appendix A, and key feedback from the survey are summarised below.

2019 Parent/ Guardian School Travel Plan Survey Results


57% of respondents agree that the FCJ School Travel Plan will **help improve safety and sustainable travel to/ from school**

84% of schoolchildren travel to school by car and almost 8% travelling by school bus.




Reason for Mode Choice




How would you prefer your child to travel to/from school?

There is a very promising 63% of parents/ guardians who would be interested in car sharing.




What would encourage parents/ guardians to car share

Parents/ guardians recognise the value of having a school bus service and 83 % states that they will or possibly will make use of the service.




Perception of safety

Other Feedback to improve safety and more sustainable travel behaviour

- Parents/guardians recognise the great work done by staff at the roundabout before school at and at the rear playground at the end of the school day
- Adjacent roads are unsafe for primary level children walking and cycling
- Consider a walking bus from Playing Fields car park (led by parents)
- More school bus pick-up points in St Helier
- Parents need to be more considerate during pick-up/ drop-off's in the school back playground
- Parents are likely to encourage children to travel to school independently when they get older (secondary)

4 Consultation and Involvement

This section outlines the involvement of the different stakeholders in the preparation of this travel plan.

School Management	The School Travel Plan is supported by the school's senior management team.
	The school Headteacher is responsible for developing and securing approval of the School Travel Plan and will take on the role of School Travel Plan Manager (STP Manager).
Parents/ Guardians	An on-line parent/guardian Travel Plan Survey was undertaken in June 2019. A total of 165 responses was obtained.
	The School Travel Plan Workshop attended by parents and school staff was held on 4/7/19 to discuss and to agree to the targets in the School Travel Plan.
Students	No consultation has been undertaken with students. This will be undertaken as part of the rolling-out stage of the School Travel Plan.
Grainville School	There is a need for close working and co-ordination between the FCJ School and Grainville School on their respective School Travel Plans. The FCJ School Travel Plan will complement the School Travel Plan for Grainville School and vice versa.
Parish of St. Saviour	The Parish supports for the development and implementation of School Travel Plans.
SoJ Growth, Housing & Environment – Operations and Transport (GHE)	GHE have been consulted for guidance on the Travel Plan development and have expressed support for the School Travel Plan.
Police Liaison on Road Safety Police Community	The School will be working closely with the SoJ Community Policing Team to support the school achieve the School Travel Plan targets.

5 Objectives, Targets and Action Plan

5.1 School Travel Plan Objectives

The School Travel Plan's objectives are:

- > To promote Health and Safety and sustainable development message to pupils and parents;
- To increase the number of pupils travelling to school by sustainable means;
- To reduce private car use for travel to school;
- > To improve safety within the school compound and on the school access roads; and
- To minimise traffic congestion/vehicular emissions.

The School Travel Plan will contribute to meeting the broader States of Jersey transport and sustainability objectives and reduce dependency n the private car for travel.

5.2 School Travel Plan Targets

Following the School Travel Plan Workshop with parents/ guardians in July 2019, the School Travel Plan and road safety targets are as follows:

5.3 Sustainable Transport & Road Safety Partnership

FCJ School and Grainville School share common transport infrastructure that provides vehicular, pedestrian and cyclist access into both schools. The School Travel Plans for both schools identify that there is a need for the schools to work in partnership with each other to promote safe and sustainable travel and to be able to meet their travel plan targets.

These sustainable transport plan actions include improving the safety for all users at the Grainville Playing Fields car park, improvements for access into car park bays along the school service road and road safety improvements for pedestrians and cyclists. Both schools would be able to share resources to roll our joint road safety campaigns, open days to promote sustainable travel and work together on minimising the compacts of construction work that will be taking place at FCJ School and Grainville School.

6 School Travel Plan Monitoring and Review

6.1 Overview

The school will monitor and report on the level of success achieved by the School Travel Plan. The first review of the Travel Plan will be undertaken after the first 6 months, after which monitoring will be carried out annually. The review will record changes in road safety, travel behaviour and impacts and consider any new travel needs arising from changes in education and transport provision.

The School Travel Plan review will take into consideration any issues arising from new developments in education and transport since the original STP was published. Feedback from schoolchildren will be carried out each term and recorded. The next monitoring will be carried out in May 2020.

6.2 Travel Plan Management

The School Headteacher is currently leading the development of the School Travel Plan. It is the intention that the Headteacher continues to act as the nominated School Travel Plan lead/manager. However, an existing member of staff could be assigned to take on this role.
